a) Meeting of the Cities, County, School Board and Authorities - Executive Director Bob White reminded the Board members of the upcoming meeting of the Cities, County, School Board and Authorities to be held at 6:00 p.m. on Thursday, February 15, 2024 at the Red Devil Hills complex in Jackson. Mr. White noted that some Board members had indicated their participation, and he urged other Board members to notify him if they planned to attend.

#### V. New Business

- a) 2024 Butts County Chamber of Commerce Magazine: Executive Director Bob White provided information on the 2024 Chamber of Commerce Magazine and noted that the Development Authority had placed a full-page advertisement in support of the Chamber of Commerce's efforts in the 2023 Chamber Magazine, and he recommended placing a full-page advertisement at the cost of \$1,200 utilizing the full-page advertisement previously used.
